Directions to The Chattanooga Choo Choo Holiday Inn

From any city on I-75: Take to I-24 West to exit 178 (Market Street), Follow Market Street for 6 blocks. The Hotel is on the right, immediately past the Main Street intersection.

From I-24 (Nashville): Take I-24 East to Chattanooga. Take exit 178 (Lookout Mountain/Broad Street). Take Broad Street south (away from Lookout Mountain) to Main Street. Turn right on Main Street. Follow two blocks to light. Turn left on Market Street and hotel is immediately on right.

Directions (approximately 8 ½ miles): From hotel location at 1400 Market Street, go right towards W. 14 Street.

Bear right on King Street. Go less than ½ mile and turn right onto E. Martin Luther King Blvd, (TN-2). Just ahead, bear right to take the ramp onto US-27 N. Go just over 5 miles. Take the Morrison Springs Road/Red Bank exit. Go less than ½ mile and turn left onto Dayton Blvd.

Just ahead, turn right onto Ashland Terrace. The animal hospital is just over 1 mile ahead, on the right.

After Hours: River Veterinary Emergency Clinic

Directions (approximately 3 miles): From hotel location at 1400 Market Street, go right out of hotel towards W. 14 Street.

Bear right on King Street. Go less than ½ mile and turn right onto E. Martin Luther King Blvd, (TN-2). Directly ahead, turn left onto Douglas Street. Go less than ½ mile and turn left onto Mabel Street. Directly ahead, turn right onto E. 4 Street. Directly ahead, bear left onto Riverside Drive (TN-58).

Go about 1 ½ miles on TN-58.

Bear left onto Amnicola Hwy/TN-58. The emergency clinic is about ½ mile ahead on the right.
