**All dogs must wear belly bands or britches when on the floor of hotel lobby, hallways, meeting rooms, etc.**

**Grooming** will be conducted in the designated grooming areas only. Please clean up after yourself and your dog(s).

**All crates** must be stacked in the grooming areas.

**No crates, grooming tables, or ringside tables** will be permitted in the Ballroom during judging. They may be permitted in the Ringside Holding area, space permitting.

**Absolutely NO grooming in the Ballroom.**

**Exercise Pens** will be permitted in designated areas only. Exercise areas will be clearly marked and ENFORCED. PLEASE CLEAN UP AFTER YOUR DOG.

**Dogs entered at these events MUST** have rabies and shot records available.

**No dogs permitted** in public restrooms.

**No space** for unentered dogs.

**An Event Committee Hearing** will result from a violation of Hotel Rules or any damage to Hotel/Motel rooms, grounds or premises. A Bench Committee Hearing will also result in any behavior that is deemed detrimental to the breed or to AKC.

### DIRECTIONS TO SHOW SITE

**From the North** - US 101 South to Exit 414B, take ramp right for Fashion Island Blvd. Turn right onto Fashion Island Blvd. Keep straight onto 19th Ave. Turn right onto Ginnever Street. Turn right onto Concar Dr. and then left onto S Amphlett Blvd.

**From the South** - US 101 North to Exit 414B, take ramp right for SR-92 West toward Half Moon Bay. At exit 12C, take ramp right toward Delaware St and then right onto Concar Dr. and then left onto S Amphlett Blvd.

**From the East** - SR-92 West to exit 12C, take ramp right toward Delaware St and then right onto Concar Dr. and then left onto S Amphlett Blvd.

**From the West** - SR-92 East to exit 12C, take ramp right and follow signs for Delaware St.. Left onto S Delaware Street. Turn right onto Concar Dr. and then left onto S Amphlett Blvd.

### RV Parking

The Marriot has space for RV parking, but they, by law, cannot allow anyone to stay in the RV's at night. The city allows a license for the Hotel, or a license for an RV park. It does not allow both. Anyone found staying in their RV during the night will be asked to leave immediately. Due to this restriction, which we agree is a disappointment, the Hotel has secured parking at the event center, 1.5 miles from the Hotel, where you can stay in your RV at night. Space is available on a first come, first serve basis, and reservations take priority. There are hookups there, but power is limited to one 30 amp plug. The cost is \$35 per night. You can call Matt Cranford to reserve your spot. Phone 650-574-3247. Transportation to and from the hotel will be on your own.
