Novice Intermediate Class: for boys & girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

Novice Senior Class: for boys & girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

Open Junior Class: for boys & girls at least 9 and under 12 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present.

Open Intermediate Class: for boys & girls at least 12 and under 15 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present.

Open Senior Class: for boys & girls at least 15 and under 18 years of age on the day of the show who at the time entries close, have won three (3) first place awards in a Novice Class at a licensed or member show, with competition present.

At the sole discretion of the judge, the following breeds may be judged on a ramp: Chinese Shar-Pei, Clumber Spaniels, Sussex Spaniels, Basset Hounds (expected to be examined on the ramp during breed judging), Irish Terriers, Kerry Blue Terriers, Staffordshire Bull Terriers, Bulldogs, Chow Chows, Keeshonden, Whippets (may be examined on the ground, on a table or on a ramp) and Polish Lowland Sheepdogs. Ramps may be used in emergency situations to judge any breed.

(In an emergency situation, the exhibitor does have the option of withdrawing their entry and receiving a refund).

A Recording Fee of 50 cents per dog and a \$3.00 AKC Event Service Fee will be required for each eligible entry entered at any Licensed or Member Club Show or Obedience Trial. These Fees are paid to the American Kennel Club. (American Kennel Club Rule, Chapter 11, Section 2).

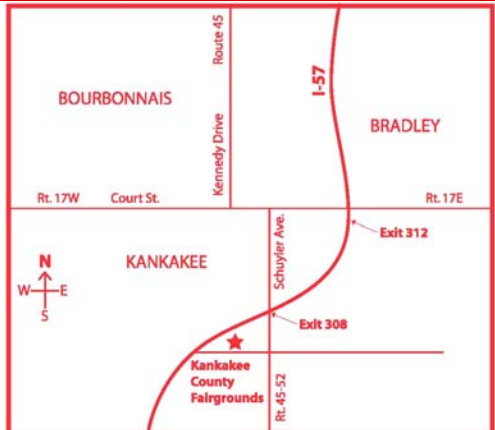

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
