Dogs may enter both the Instinct Test and Novice class in the same trial *until the dog has earned the RATN title and then they cannot enter the Instinct Test*. Dogs completing the RATN in the first trial may be moved up to Open for the second trial. This is up to the handler and not required. Move-up forms will be available at the Secretary's table.

Notice to Exhibitors:

- These trials will be outdoors on the tennis courts.
- There are indoor restrooms at the site.
- The **Sawmill Creek Resort** has areas close to the tennis courts where they do not want you to potty your dogs, so please follow instructions and please pick up after you dog(s).
- This event is open to all dogs 6 months of age and older.
- Any of the Judges of Record for this event may be used to judge any of the classes at this event at the discretion of the Club under the rule provisions for Load Balancing, Relief Judging, and Splitting. Qualifying scores are assigned to the official Judge of Record for that class.
- Withdrawal of entry before the closing date will receive a full refund.
- Refunds for dogs pulled before closing will be mailed 7 days after the event.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee. Exception - Injured dogs with a note from their Veterinarian will receive a refund less the \$5 processing fee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when in the ring.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- All entries must be accompanied by entry fees in US funds to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to Dalmatian Club of America. There is a \$3 convenience charge for payment by PayPal. Entries where payment has not been received within 7 days of receipt of entry will be cancelled.
- Trials site and judging ring are handicapped accessible.
- At no time can dogs be tied out or otherwise left attached to anything other than a human when outside a crate, car, or other secure enclosed confinement. Leashes cannot be left dangling or dragging. Standing or stepping on a leash is not allowed as a form of restraint (but may be used in an emergency to help secure a loose dog.) Accommodations to this rule may be made for differently-abled handlers as determined by the Club.
- There is a lunch concession on site
- **Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial in panties.** If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.
- **ONLY DOGS THAT ARE ELIGIBLE** to be shown under the American Kennel Club rules **and or Barn Hunt Association LLC** shall be allowed within the Show Precincts. Sawmill Creek Resort is the show site. Puppies under four (4) months are not allowed.
- Sawmill Creek Resort tennis courts will be available to exhibitors during trial hours only.
- **The show-giving club, the Show Superintendent, and Sawmill Creek Resort, assume no responsibility for any loss, damage or injury sustained by the exhibitors, handlers or to any of their**

dogs or property.

- No dogs allowed in rest rooms & no washing of animal food containers in rest rooms. Bathing of dogs limited to bathing area.
- Exercise dogs in designated areas only.
- **No videotaping or photography during the events for resale is permitted without Dalmatian Club of America, Inc. approval.**
- No unentered dogs or puppies allowed in building per AKC guidelines.
- No working (practice) in rings before or after show hours. Dogs are allowed in rings only during judging hours and scheduled practice times.
- **EXHIBITORS & GUESTS: No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance." No firearms allowed on the Sawmill Creek Resort property. Violators will be reported to the AKC. No Smoking (including electronic cigarettes) in the Building. No push pins, nails or any type of things going into the walls. No adhesive other than Hotel approved tape should be used to affix a sign to a wall. Masking tape or command strips may be used. UNLOADING/PARKING: No driving on grass areas.**
- **All AKC and or Barn Hunt Association LLC Rules & Regulations will be enforced by the Show Event Committee under AKC and or Barn Hunt Association LLC guidelines. . Failure to comply with these rules will result in charges being brought before the Show Event Committee. Any event hearing, disciplinary action, rule violations, complaints, or charges will be resolved by the Dalmatian Club of America, Inc. National Specialty Event Committee. Show Event Committee members are: Toni Linstedt, Chair, Dr. Charles Garvin, Kevin O'Connell, Paula Olcott, SarahAnne Vancleave, Meg Hennessey and Linda Lombardi.**
- The show-giving club assumes no responsibility for the welfare of children & further expects exhibitors and spectators to keep their children under strict control.
- Unless otherwise specified, all trophies must be claimed the day of the show. None will be mailed, except for those trophies that have been specified herein. The club reserves the right to substitute a prize of equal or greater value.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
- **This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.**
- **Please be advised:** when an exhibitor/handler brings a dog to the podium for a win/placement photo they are establishing a de facto contract with the show photographer to purchase that photo.
- **VOLUNTEERS:** In order for these tests to run smoothly we would appreciate your help. NO EXPERIENCE NECESSARY. We will be glad to train you. We will ensure the schedule is adjusted to allow time for all volunteers to run their own dogs
