Directions

From I-75 Southbound: I-75, Exit 261. Lockheed/Dobbins AFB (GA 280). Drive 5.3 miles. Turn right onto Austell Road. Right turn onto Callaway Road. Jim R. Miller Park will be on your right. Note: Allow extra time on Friday due to workday congestion.

From I-75 Northbound: I-75 to second exit after I-285 Perimeter staying as far right as possible. Keep in the left lane of the two exit lanes at Exit 261. Lockheed/Dobbins AFB (GA 280). Drive 5.3 miles. Turn right onto Austell Road. Right turn onto Callaway Road. Jim R. Miller Park will be on your right. Note: Use I-285 north on Friday to avoid workday congestion through Atlanta. **FROM THE WEST OR EAST:** I-285, Exit #15 (S Cobb Dr, GA 280): North on GA 280 to Windy Hill Rd. Left onto Windy Hill. Left onto Austell Rd. Right onto Callaway Rd (1st traffic light). Right into Jim R Miller Park.

FROM THE WEST OR EAST: I-20, EXIT #44 (THORNTON RD): North on Thornton Rd to Maxham Rd. (Large shopping center at top of hill on right.) Right onto Maxham Rd. (Name changes to Austell Road - Hwy. 5). Left onto Callaway Rd. (7.3 miles) Right into Jim R Miller Park.

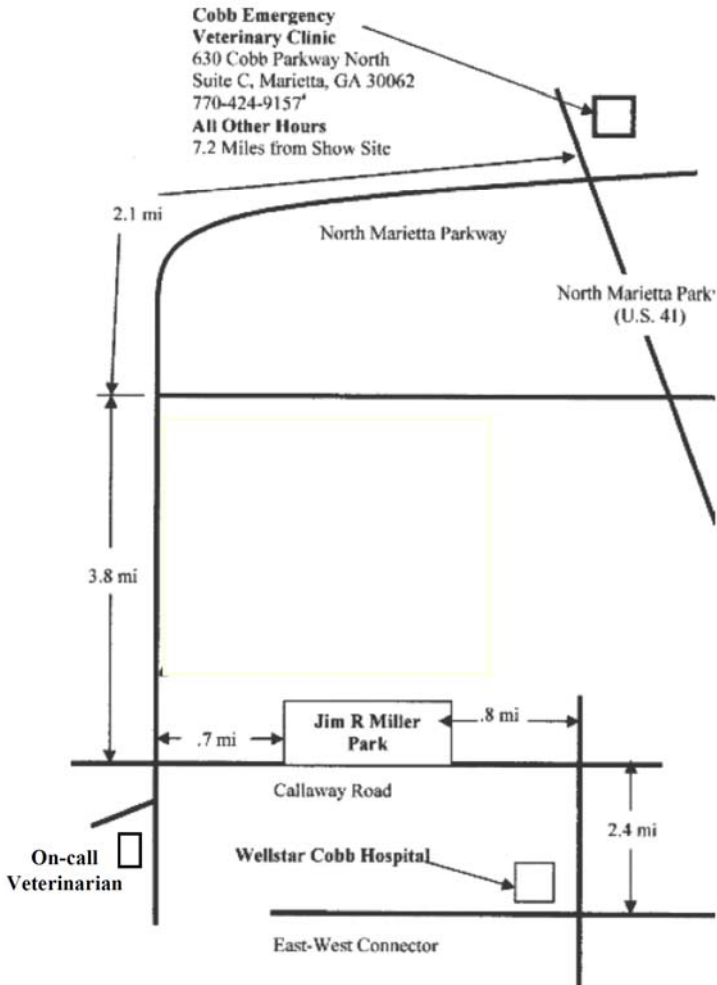

JIM R MILLER PARK will not be available to exhibitors before 10:00am Thursday, October 27, 2016 unless prior arrangements have been made. Dogs must be removed from the show site immediately following Best In Show judging on Sunday, October 30, 2016. Pursuant to the regulations of the Cobb County Parks Department: VEHICLES STAYING OVER SUNDAY NIGHT MUST PAY IN ADVANCE AND BE REMOVED BY 10:00AM MONDAY MORNING UNLESS ARRANGEMENTS ARE MADE AT THE PARK OFFICE. ABSOLUTELY NO UNPAID PARKING WILL BE ALLOWED ON THE PARK GROUNDS SUNDAY NIGHT AFTER 10:00 PM. VIOLATORS MAY BE SUBJECT TO AKC SANCTIONS AND POSSIBLE CRIMINAL CHARGES.

ALL VEHICLES SHALL BE PARKED IN DESIGNATED PARKING AREAS. VEHICLES PARKED IN DESIGNATED UNLOADING/LOADING ZONES MUST BE REMOVED IN 15 MINS. ANY VEHICLE PARKED IN AN UNAUTHORIZED AREA MAY BE SUBJECT TO TOWING AT THE OWNER'S EXPENSE.

All vehicles must follow the parking signs located along Callaway Road and any instructions given by parking staff. Unloading access is through the RV entrance located on Al Bishop Rd. RINGSIDE TABLES AND CRATES WILL BE ALLOWED AGAINST THE WALL ONLY, temporarily in Buildings A or B or at ringside in the Pavilion Area, DURING THE JUDGING OF THAT BREED, PROVIDED THAT IN THE OPINION OF THE SHOW COMMITTEE, NO OBSTRUCTION OR SAFETY HAZARD IS CREATED. All tables and crates must be REMOVED IMMEDIATELY from the area following the judging of the breed.
