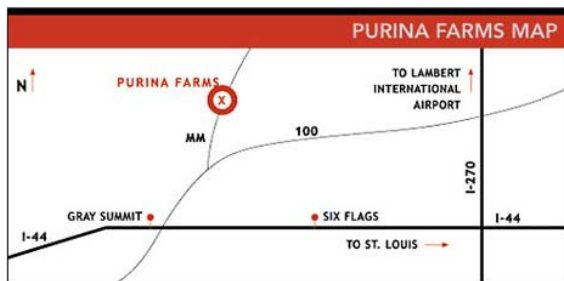

Routes to the Show

Purina Farms is located just 10 minutes west of Six Flags outside of St Louis on I-44. Take the Gray Summit Exit & go North two blocks on Highway 100. Turn left on County Rd MM & proceed less than one mile to Purina Farms (entrance is on the left.) **PLEASE NOTE – THE ENTRANCE TO THE PURINA EVENT CENTER HAS CHANGED – THE NEW ENTRANCE IS ON THE LEFT BEFORE THE OLD ENTRANCE AND JUST PAST THE SHEEP BARN.**

* **DCA HOTEL POLICY:** There is a \$50.00 non-refundable pet fee for the hotel rooms. There are to be no more than 4 dogs to a room. "Any exhibitor who allows his/her dogs to be loose & unattended in a room or to damage hotel property & does not immediately contact the hotel management to make proper restitution will be subject to a Show Event Committee action which could result in the loss of AKC privileges." If it is determined by the Committee hearing that rules are being neglected & destruction and/or misuse of property is taking place, the Committee has the authority to correct the problem or seek AKC suspension.

ATTENTION EXHIBITORS

All dogs must be kept on leash, except when in the obedience ring.

ONLY DOGS THAT ARE ELIGIBLE to be shown under the American Kennel Club rules shall be allowed within the Show Precincts. Purina Farms is the show site. Puppies under four (4) months are not allowed.

The Event Center will be available to exhibitors from 4:00 PM – 6:00 PM on May 20, 2017.

There will be 6000 square feet of day crating space available in the Great Hall. DCA reserves the right to require that all crating must be stacked. This will be the only area where crating will be permitted. There will be no ringside crating for conformation. Dogs may be crated in the area from 6:00 AM until 6:00 PM on May 21 and from 6:00 AM until 10:00 PM on May 22 - 26. DOGS MAY NOT BE LEFT OVERNIGHT. NO CRATES MAY BE PLACED DIRECTLY ON THE FLOORING SURFACE IN THE GREAT HALL. THERE MUST BE PLASTIC OR A RUG UNDER THE CRATE. ALL GROOMING TABLES MUST HAVE RUBBER OR PLASTIC CAPS ON THE END OF THE LEGS OF THE TABLE.

The show-giving club, the Show Superintendent, Purina Farms, Sullivan Airport, the land owners or The Wildwood Hotel assume no responsibility for any loss, damage or injury sustained by the exhibitors, handlers or to any of their dogs or property.

No dogs allowed in rest rooms & no washing of animal food containers in rest rooms. Bathing of dogs limited to bathing area, located in the red Service Building next to the full hook-up RV Lot.

Exercise dogs in designated areas only.

No videotaping or photography during the events for resale is permitted without Dalmatian Club of America, Inc. approval.

No grooming allowed in the Great Hall except in the designated crating area.

No unentered dogs or puppies allowed in building per AKC guidelines.

No working (practice) in rings before or after show hours. Dogs are allowed in rings only during judging hours and scheduled practice times.

EXHIBITORS & GUESTS: No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance." These are separate divisions of Purina and are not part of the show grounds. No dogs are allowed, except for service dogs on the second floor of the Purina Event Center (unless given prior permission). There are no baby strollers allowed inside the building. No cones allowed inside building. No firearms allowed on Purina Property. No outside food or beverage is allowed in the Purina Event Center or other venues. Violators will be reported to the AKC. No Smoking (including electronic cigarettes) in the Building. No helium balloons allowed in either Hall. No glitter or confetti allowed in the facility. No Duct Tape to be used in the facility. Only painter's tape or gaffer's tape may be used.

UNLOADING/PARKING: Exhibitor and visitor parking will be located on blacktop parking lots in front of the Purina Event Center. Vehicles are limited to one parking space. No Ex-Pens or Crates allowed on blacktop, but are allowed on grass areas. No driving on grass areas. No cones allowed in parking areas. No parking in roadways or next to building. All vehicles must leave their headlights/emergency flashers on while unloading. **All exhibitors must abide by the 15-minute unloading/loading parking time limit designated around the Purina Event Center. NO VEHICLES MAY BE PARKED NEXT TO BUILDING OR IN ANY ROADWAY. VIOLATORS WILL BE TOWED AT OWNER'S EXPENSE. NO CAR PARKING IN RV LOT WITHOUT RV RESERVATION.**

All AKC Rules & Regulations will be enforced by the Show Event Committee under AKC guidelines. Failure to comply with these rules will result in charges being brought before the Show Event Committee. Any event hearing, disciplinary action, rule violations, complaints or charges will be resolved by the Dalmatian Club of America, Inc. National Specialty Show Event Committee and the Specialty Steering Committee Chairman, who also serves as the Show Event Committee Chairman. The show-giving club assumes no responsibility for the welfare of children & further expects exhibitors and spectators to keep their children under strict control.

Unless otherwise specified, all trophies must be claimed the day of the show. None will be mailed, except for those trophies that have been specified herein. The club reserves the right to substitute a prize of equal or greater value.

This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Please be advised: when an exhibitor/handler brings a dog to the podium for a win/placement photo they are establishing a de facto contract with the show photographer to purchase that photo.
