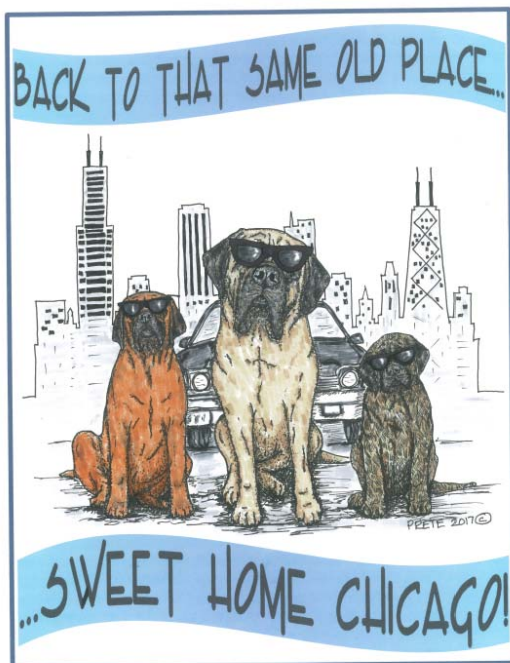

All functions will be held under the AKC Code of Sportsmanship, Code of Ethics, and AKC Rules & Regulations as is any AKC sponsored event.

ETHICS: HONESTY AND COMMON SENSE

AKC judges possess and project a commitment to integrity and ethical behavior that insures the reputation of AKC dog shows as fair and well judged. With common sense, judges can easily avoid situations which might raise ethical questions.

Judges and exhibitors are honest, competent and dedicated. Nevertheless, it is possible to find yourself in an uncomfortable or inappropriate situation. These guidelines cannot address every situation; however it can help you avoid improprieties perceived or otherwise.

Obviously, some rules, policies and guidelines are clear. For example:

1) Judges should advise potential exhibitors not to enter under you when their presence or the presence of their dogs might give the impression of unfair advantage. Examples include but are not limited to:

...your employer or an employee.

...a relative.

...a person with whom you co-own dogs.

...a person with whom you co-breed dogs.

...a person with whom you travel to dog shows.

2) Exhibitors should not enter under a judge when their presence or the presence of their dogs might give the impression of unfair advantage. Examples include but are not limited to:

...your employer or an employee.

...a relative.

...a person with whom you co-own dogs.

...a person with whom you co-breed dogs.

...a person with whom you travel to dog shows.

3) *No entry shall be made at any show under a judge of any dog which said judge or any member of his immediate household or immediate family has been known to have owned, handled in the ring more than twice, sold, held under lease or boarded within one year prior to the date of the show. These are only examples. The key is to avoid all situations that are likely to give the impression of impropriety. You must do everything possible to keep your reputation above reproach.*

A HANDY RULE OF THUMB

There will always be “gray areas” that perplex judges and exhibitors. When faced with such a dilemma, ask yourself whether the situation, however innocent, projects an outward appearance of impropriety. A good rule of thumb is:

If you have concerns about whether something is inappropriate, you probably should avoid the situation.

CHAPTER 11, SECTION 1. No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. The Mastiff Club of America, Inc. will award at its National Specialty a three point major to Reserve Winner's Bitch if the Regular Class Bitch entry is twice the required number for a five point major in the division where the National Specialty is held.

TRANSFER POLICY FOR THE SPECIALTY AND TRIALS: The Club will permit a transfer to the next level class in accordance with AKC regulations. The request for a Transfer must be made in writing and presented to the Superintendent at least 30 minutes prior to the start of the specified event, show or trial. Non-Regular Classes Involving Multiple Dog Entries

NOTE: As the judge's decision in the Stud Dog, Brood Bitch, Brace, and Team Classes is based upon the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won in these classes.

STUD DOG CLASS - For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the Regular or Non-Regular Classes or if a Champion of Record, for Best of Breed/Variety Competition or may be entered for Stud Dog Class only at the regular entry fee. The Get **MUST** be entered in one of the Regular or Non-Regular Classes. The Stud Dog unit shall be considered as one entry and requires only one entry fee. The Stud Dog must be entered in the Stud Dog Class and shown in the ring with their Get. Get only to be judged on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under AKC Rules Applying to Dog Shows, AKC Policy or Standard for the Breed.

BROOD BITCH CLASS - same as for the stud dog except substitute brood bitch for stud dog and produce for get.

NOTE: Chapter 11, Section 8, AKC Rules Applying to Dog Shows provides that castrated males may be entered as Stud Dog and spayed females may be entered as Brood Bitch.

BRACE CLASS (National Only)- Two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs in the Brace must have at least one common owner. Dogs comprising a Brace must be named at the time of entry. If a dog which is to be part of a Brace is **NOT ENTERED** in another class at this show, it must be entered for "BRACE CLASS ONLY". In making entries for "Brace Class Only", full particulars must be given on an Official AKC Entry Form. If the dog is entered in another class, Brace must be marked as an "Additional Class". If more than one Brace is entered by an individual owner, please designate dogs comprising each Brace as "Brace # 1", "Brace # 2", etc.

TEAM CLASS (National Only) - A team is defined as four dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of four handlers. All dogs competing in team competition must have at least one common owner. The dogs comprising a Team **MUST** be named at the time of entry. If a dog which is to be part of a Team is not entered in any of the Regular Classes or for "Best of Breed Competition," it must be entered for "Team Only". In making entries for "Team Only" full particulars must be given for each dog on individual regular entry forms. An entry for a dog entered in a Regular Class or for "Best of Breed Competition" and entered as a part of a Team **MUST** be marked accordingly in the space provided for Additional Classes - Team Class. If more than one Team is entered by the same owner, the dogs comprising **EACH** Team must be so designated "Team No. 1", "Team No. 2", etc.

Special Competition

To be judged immediately following Brace and Team judging.

Only dogs not defeated in a regular class are eligible for each Special Competition

Best Puppy in Regular Puppy Classes

For winners of the Puppy Dog & Puppy Bitch 6-9 Months and 9-12 Months classes only.

Best Bred By Exhibitor

For winners of the Bred By Exhibitor Dog & Bred By Exhibitor Bitch classes only.

Best Veteran

Best Veteran Dog & Best Veteran Bitch from the Veteran classes only.

Award of Merit (National & Regional)

Following the Best of Breed/Variety, Best of Opposite Sex to Best of Breed/Variety and Selects have been awarded; the judge may select Award of Merit Winners from the remaining dogs and bitches in competition. The number of these awards is 10% of the Best of Breed Entry.

These Awards of Merit are reserved for those quality animals the judge feels are worthy of final consideration for Best of Breed. The dogs selected for Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, & Select Bitch are not eligible for an Award of Merit.

Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary at least one-half hour prior to the scheduled start of Junior Showmanship judging at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have won three (3) first place awards, with competition present, in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry.

You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767. Entry blank **MUST** be filled out with the necessary information, otherwise the entry in Junior Showmanship will not be accepted.

NOTICE: JUNIORS WHO SUBSTITUTE FOR THE ORIGINAL DOG THEY HAVE ENTERED IN THE JUNIOR SHOWMANSHIP CLASSES WITH DOGS THAT ARE NOT ENTERED IN ONE OF THE OFFERED CLASSES AT THIS SHOW MUST REMIT THE JUNIOR SHOWMANSHIP ONLY ENTRY FEE WITH THEIR SUBSTITUTION.

All trophies are offered by the Mastiff Club of America, Inc. unless otherwise noted. The MCOA reserves the right to substitute a trophy of equal or greater value for any award listed. Trophies must be claimed the day of the show. None will be mailed. All sponsors of classes and awards will be listed in the show catalog.

BREED PERPETUAL TROPHIES

Best of Breed - The MCOA offers at its Specialty Show, a Silver Cup for Best of Breed. This trophy was presented to the Mastiff Club of America by the Old English Mastiff Club in 1932 and is not offered outright, but will be presented in the ring to the person handling the dog. The name of the dog awarded Best of Breed and the year will be engraved on the trophy as a permanent record. The trophy will remain in the possession of the MCOA Trophy Chairperson.

Best of Breed - The Mastiff Club of America offers the Michael Gensburger Memorial Best of Breed Trophy. This trophy to honor Mike and remind us of his contributions and dedication to MCOA and the English Mastiff. First presented at the 2003 National Specialty and to be presented each year thereafter, the Best of Breed winner will have their name and year displayed on an 18 x 24 Walnut Board as a permanent tribute. The Best of Breed winner will receive a 9" x 12" Greystone Plaque to commemorate the occasion.

Winners Dog - The MCOA offers at its Specialty Show a Silver Cup for Winners Dog. This trophy is for display and pictures only. The name of the Winners Dog, and the year will be engraved on the trophy as a permanent record. The trophy will remain in the possession of the MCOA Trophy Chairperson. The Winners Dog will receive a 9" x 12" Greystone Plaque to commemorate the occasion.

Winners Bitch - The MCOA offers at its Specialty Show a Silver Cup for Winners Bitch. This trophy is for display and pictures only. The name of the Winners Bitch, and the year will be engraved on the trophy as a permanent record. The trophy will remain in the possession of the MCOA Trophy Chairperson. The Winners Bitch will receive a 9" x 12" Greystone Plaque to commemorate the occasion.

National Futurity/Maturity Stake Rules

PURPOSE

The purpose of the MCOA Futurity and Maturity is to encourage the breeding of the best possible Mastiffs, reward diligent MCOA breeders for their efforts, recognize the owners for selecting the best quality puppies from responsible breeders, and reward the owners and breeders for raising and developing the inherited qualities of the puppy.

In nominating a litter for the Futurity, MCOA members are casting their vote of confidence in their breeding decisions and indicating their commitment to improving the quality of our mastiffs.

In addition, the Maturity Stakes not only provide Futurity-nominated puppies with an additional opportunity to compete but also gives those unable to participate in a futurity the chance to compete during the next National Specialty in the Maturity stakes.

GENERAL

Key steps for this are:

1. Nominate litter: \$25 per litter, split \$15 to Futurity, \$10 to Maturity.
2. Nominate puppies: \$25 per puppy, split \$15 to Futurity, \$10 to Maturity.
3. Enter at upcoming National Specialty based on age of the puppies.

Nomination forms may be secured from the MCOA Website.

Mail **Forms** to Futurity/Maturity Director.

Mail **Checks** to MCOA Treasurer with "Futurity/Maturity nomination" in memo section, or pay via **PayPal**.

DIVISION OF STAKE MONEY

GENERAL

25% to operating expense fund.

75% to be divided for futurity prize money.

Division of Futurity prize money

10% to Best in Futurity Stakes.

3% each to Best Futurity Puppy and Best Futurity Junior

2% each to BOS Futurity Puppy and BOS Futurity Junior

The 80% remaining will be split for the classes, pro-rated by the number of dogs entered in each class, with 40% going to first place, 30% to second, 20% to third place, and 10% to fourth place.

Division of Maturity prize money

10% to Best in Maturity Stakes.

3% each to Best Maturity Junior and Best Maturity Senior

2% each to BOS Maturity Junior and BOS Maturity Senior

The 80% remaining will be split for the classes, pro-rated by the number of dogs entered in each class, with 40% going to first place, 30% to second, 20% to third place, and 10% to fourth place.

Division of Prize money for Futurity and Maturity

40% to Breeder. 60% to Owner.

Prize money is awarded and claimed only at the National Specialty. Unclaimed checks will be returned to MCOA General income.

Futurity/Maturity Approved Motions:

Effective 2007 Futurity the Futurity/Maturity Director is eligible to participate in Futurity/Maturity Competition.

Effective per Motion Oct 2017 There is no longer an award for Best of Opposite Sex to Best in Futurity or to Best in Maturity.

STEP 1. NOMINATION OF LITTER

Nomination must be made by be a MCOA member and be the breeder or co-breeder.

Nomination must be made after the breeding, but before puppies are whelped. The postmark on the entry envelope is the official date of nomination.

Nomination fees cannot be transferred from one litter to another nor from one bitch to another. There will be no refunds.

The nomination of a litter makes all puppies in the litter eligible for individual nomination in both Futurity and Maturity.

STEP 2. NOMINATION OF PUPPY

Nomination must be made by the legal owner or co-owner of the puppy as of the date of nomination.

Nomination must be made before the puppy reaches four (4) months of age. The postmark on the envelope is the official date of nomination.

The nomination form should include a copy of the current AKC registration.

There will be no refunds.

An entire litter may be individually nominated by the breeder for Futurity and Maturity before puppies are sold by paying fee for each puppy and supplying (for each puppy):

- Litter Registration Number
- Whelping Date
- Name
- Sex

STEP 3. ENTER FUTURITY STAKES

REQUIREMENTS TO ENTER FUTURITY JUDGING

The puppy must be entered in one of the regular classes, either in conformation or obedience at the MCOA National Specialty Show. All entries must be paid in full.

The Futurity entry must include:

- Futurity entry **must** be indicated as an additional class and include the age division (e.g., Futurity 6-9, etc.)
- Futurity Classes range in age from six months through the eighteenth month (until the dog is nineteen months old). The classes will be divided as such:
 - 6 to 9 months, Puppy
 - 9 to 12 months, Puppy
 - 12 to 15 months, Junior
 - 15 to 18 months, Junior

Puppies are eligible **only** for the first Futurity Stake Show that is held in conjunction with the first MCOA Specialty Show held on or after the date the puppy reaches six (6) months of age.

Individuals **handling** the dogs in Futurity Competition must be:

- An Owner or Co-owner or
- A Breeder or Co-Breeder or
- An MCOA Member or Associate MCOA Member in good standing* with MCOA and AKC.
This includes professional handlers.

*In Good Standing – members and associate MCOA members that are not in a suspended status with AKC or MCOA.

STEP 4. MATURITY STAKES

REQUIREMENTS TO ENTER MATURITY JUDGING

Maturity entries are eligible to compete only in the first Maturity Stake held following the Futurity stake for which they were nominated.

While the nomination must have been made for Futurity, entry or participation in the Futurity Stakes is not required for Maturity judging. Thus, if a puppy is not able to attend their futurity year, they may still enter in maturity the following year.

The dog entering a Maturity class **must** be entered in one of the regular classes, either in conformation or obedience at the MCOA National Specialty Show. All entries must be paid in full.

The Maturity entry must include:

- Maturity entry **must** be indicated as an additional class and include the age division (e.g., Maturity Under 24 Months or Maturity Over 24 Months)

- Maturity **Class divisions** are:
 - Junior - Under 24 Months
 - Senior - Over 24 Months
 - 12 to15 months, Junior
 - 15 to18 months, Junior

Individuals **handling** the dogs in Maturity Competition must be:

- An Owner or Co-owner or
- A Breeder or Co-Breeder or
- An MCOA Member or Associate MCOA Member in good standing* with MCOA and AKC. This includes professional handlers.

*In Good Standing – members and associate MCOA members that are not in a suspended status with AKC or MCOA.

SEQUENCE OF JUDGING - Futurity

Step 1: Judging sequence will be all dog classes (6-9 month through 15-18month) followed by all the bitch classes.

Step 2:

- a. The judge will have the first-place winners of the **6-9 and 9-12 dog and bitch** classes return to the ring to select a Best Futurity Puppy and a Best of Opposite Sex Futurity Puppy.
- b. This sequence will be repeated for the first-place winners of the **12-15 and 15-18 dog and bitch classes** and the judge will select a Best Junior and Best of Opposite Junior winner.

Step 3: The Best Puppy and Best Junior Puppy compete for Best in Futurity Winner.

SEQUENCE OF JUDGING - Maturity

Step 1: Judging sequence will be all dog classes (Junior- Under 24 months and Senior-Over 24 months) followed the bitch classes.

Step 2:

- a. The judge will have the first-place winners of the **Junior- Under 24 months dog and bitch** class return to the ring for the judge to select Best Maturity Junior, followed by Best of Opposite Sex Maturity Junior.
- b. This sequence will be repeated for the first-place winners of the **Senior-Over 24 months dog and bitch** class and the judge will select a Best Maturity Senior, followed by Best of Opposite Sex Maturity Senior.

Step 3: Best Maturity Junior and Best Maturity Senior will compete for Best in Maturity.

TROPHIES AND RIBBONS - Futurity

A trophy and rosette will be provided for:

- Best In Futurity Puppy
- Best of Opposite Sex to Futurity Puppy
- Best in Futurity Junior
- Best of Opposite Sex to Futurity Junior
- Best in Futurity Winner

TROPHIES AND RIBBONS - Maturity

A trophy and rosette will be provided for:

- Best In Maturity Junior
- Best of Opposite Sex to Maturity Junior
- Best in Maturity Senior
- Best of Opposite Sex to Maturity Senior
- Best in Maturity Winner

The Best in Futurity and Best in Maturity Winners ribbon and trophy will be **purchased from the Futurity/Maturity operating funds**. Other trophies and rosettes may be awarded at the discretion of the National Specialty Show Committee.

Ribbons will be awarded for each 1st – 4th placement. Duplicate copies of ribbons for the owners/co-owners or breeders/co-breeders may be purchased by requesting them from the National Ribbon Chairperson within 30 days after the national.

SUMMARY OF MAJOR RULES for Futurity/Maturity Stakes

- Litter must be nominated before litter is whelped.
- Puppy must be nominated before puppy reaches four (4) months of age.
- Futurity is an **additional class** at the National Specialty, and the entry must so indicate on the official AKC entry.
- Maturity is an **additional class** at the National Specialty, and the entry must so indicate on the official AKC entry.

Judges for Round 2 will not be announced until the time of the Round 2 event. In the event of a last-minute judge change, entrants that may have a potential

conflict of interest may request a refund of the entry fee. The judge also has the right to refuse to examine a dog if they feel there is a conflict of interest.

Round 1 (Daytime Judging)

1. All mastiffs enter the ring in numerical order and are checked in. Each dog will exit the ring.
2. The first set of three will come into the ring, one at a time and make an entire circle around the ring and stop at station 1, 2 and 3 after the first time around the ring.
3. The judges will be at three set stations in the ring for the hands-on examination. The mastiffs will move counter-clockwise until all three judges have examined all three dogs. Each round of judging should be limited to three minutes a dog in total. Dogs will not be moved individually by a judge during hands-on examination.
4. Complete the score sheet after each individual exam. The Score sheet will be handed over to the Tournament chairperson or designee.
5. When each dog in the trio has been examined by each judge, the dogs will be moved individually on a diagonal down and back. Finally as a group they will be moved once around the ring and then exit.
6. Final scoring of the group is completed, judges will review the score sheet to be sure all areas are scored and hand them in.
7. The second group of three mastiffs enters the ring. This continues until all mastiffs have been examined.

8. The score sheets will be tallied.
9. Please note: In the event of a tie score in the top ten qualifiers, the 15 top scoring mastiffs will be brought back into the ring for the judges to review scores. The mastiffs with a tie will be denoted with an asterisk. Scores sheets will be recalculated.
10. The top ten qualifying mastiff scores will be announced ringside after the day judging session.
11. The top ten qualifying mastiffs will return for the formal evening competition.
12. Owners/handler will be asked to provide a short bio of the dog to be read during the opening ceremony.

Round 2

(Evening Semi-Formal Judging for FINAL TOP TEN)

Opening

1. Evening competition is a semi-formal event for the exhibitor and judges.
2. The judges will not be present for the presentation of the top ten qualifiers.
3. The mastiffs will enter in armband order, not in top score order.
4. Each mastiff will enter individually and gait around the ring, with a free stack in the center of the ring. The mastiff will make a final gait around the ring and then exit into the holding area.
5. The second mastiff enters, the process repeats until all have been presented.

Top 10 Evening Judging

1. The first set of three will enter the ring, one at a time and make an entire circle around the ring and stop at station 1, 2 and 3 after the first time around the ring.
2. The judges will be at three set stations in the ring for the hands-on examination. The mastiffs will move counter-clockwise until all three judges have examined all three dogs. Each round of judging should be limited to three minutes a dog in total. Dogs will not be moved individually by a judge during hands on examination.
3. Complete the score sheet after each individual exam. The Score sheet will be handed over to the Tournament chairperson or designee.
4. When each dog in the trio has been examined by each judge, the dogs will be moved individually on a diagonal down and back. Finally, as a group they will be moved once around the ring and then exit.
5. This process continues until all finalists are judged.
6. Please note: Should there be a tie in the top 5 qualifying scores, all ten of the mastiffs will be asked to return to the ring for judges review of scores. An asterisk will be placed on the score sheets of the tie scores for judges to review. There will be no hands on during this portion of judging.
7. Score Sheets are reviewed and handed in. Judges will be escorted back to their seats.
8. Each Mastiff will then enter the ring by armband number along with their owners and a short bio will be read to the public about each dog.
9. The scores are tabulated, and winners will be announced at the Awards Banquet as per policy.
10. Score sheets summaries for all dogs entered in round one and two will be available to exhibitor entrants in a sealed envelope at the Awards Banquet. Qualifying scores will be reflected on the sheet, so the owner/exhibitor can review.

The Breeders Cup will be held before the actual judging of the Specialty classes. In this competition, each entry consists of a trio of dogs bred by the same breeder or co-breeder. Each trio is to be judged by a three-judge panel of experts on the breed, using a point system.

BREEDERS CUP PROCEDURE

1. The total Breeders Cup entry will not be brought into the ring together.
2. In numerical order, the first three trios of mastiffs will enter the ring. (Nine dogs at a time).
3. Each judge will take a trio for the hands-on exam.
4. The scoring is based on the presentation of the trio as a whole.
5. The judges will work through the first three sets until each judge has completed the hands-on examination of each dog.
6. Each dog in the trio will be gaited and restacked. Then each trio will move to the end of the line. Judges will complete the scoring (using one score sheet for each trio) and turn in those score sheets.
7. Judging will continue in this manner until all groups are judged.
8. Score sheets will be tallied and the top five (5) groups (15 dogs total) will re-enter the ring for final judging.
9. Score sheets will be returned to the judges and the judges will review their scores, making any changes in their scoring by drawing a line through previous score(s) and writing new score to the right of the old score.
10. The time allotted for final review will be kept to a maximum of 15 minutes. Judges will **NOT** re-examine any dog at this point.
11. Score sheets are then turned over to the designated Statistician for final tabulation.
12. The Statistician will provide the results in a sealed envelope directly to the MCOA President who will announce the winners and deliver awards to those winners at the Awards Banquet.
13. The Top Five award winners grand Totals of the three judging sheet results will be posted in the MCOA Journal National edition. Copies of the individual results for all entrants will be available in a sealed envelope for each Breeder/Co-Breeder at the conclusion of the National, after which time, if not retrieved, they will be destroyed.

Canine Good Citizen, CGC/CGCA and Therapy Dog International Tests

Tester: Becky Campbell

The AKC's Canine Good Citizen® (CGC) Program, started in 1989, is a certification program that is designed to reward dogs who have good manners at home and in the community. The Canine Good Citizen Program is a two-part program that stresses responsible pet ownership for owners and basic good manners for dogs. All dogs who pass the 10-step CGC test may receive a certificate from the American Kennel Club. Both purebred and mixed breed dogs are eligible for the certificate. See www.akc.org/events/cgc for more information.

TDI's canine membership includes both purebred dogs and mixed breed dogs. All dogs are tested and evaluated for Therapy Dog work by Certified TDI Evaluators. The TDI test is based upon the AKC's CGC test, and also includes the evaluation of the dog's behavior around people with the use of some type of service equipment (wheelchairs, crutches, etc.). See www.tdi-dog.org for more information.

AKC Community Canine—CGCA

The AKC Community Canine is the advanced level of the Canine Good Citizen Program. As with CGC, the AKC Community Canine has a 10-step test of skills that dogs must pass to earn the official AKC Community Canine Title. This is a title that appears on the dog's title record at AKC.

The Canine Good Citizen tests are simulation of real world skills. The AKC Community Canine is to test the dog's skills in a natural setting.

To earn the AKC Community title, dogs must meet the following two requirements:

Must already have a Canine Good Citizen Title on record at AKC.

Must have an AKC number. (AKC registration, PAL number or AKC partners number).

The test requirements can be reviewed by going to the AKC site.

Testing will be performed by Becky Campbell. The CGC/CGCA/TDI test is usually given as a combined test, meaning that you are being tested for BOTH CGC and TDI certification. You may elect to do just CGC or modifications will be added to the test to qualify for Therapy Dog Certification. A dog must be at least one year old to be tested for TDI and must pass the CGC. If the dog has previously passed the CGC, then proof must be provided before the TDI test can be given. If you have any questions, please contact Becky Campbell at bjccle@aol.com.

Your dog must be wearing a well-fitted buckle collar (no chain or prong collars) to participate in the testing.

Entry fee is \$15.00 for CGC & CGC-A or \$25.00 for CGC or CGC-A with TDI modifications.

Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. - Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
