Show grounds will be available at 6:00 A.M. on Saturday and Sunday, March 30 & March 31, 2019. No Dogs will be allowed in the grounds overnight at these events. DOGS MUST be removed from the grounds immediately following Best in Show each day. GATE opens at 6:00 A.M. Saturday & Sunday, March 30 March 31, 2019, the gate closes at 10:00 P.M. every night.

PARKING

Day parking OUTSIDE the fence is FREE. Parking in the north lot beyond the admission gate and behind the stables near the arena is \$5.00 per day. Stalls rented for reserved grooming will include 1 parking space and electric hookup in front of the rented stall. Only reserved grooming cars may park in front of those stalls. The reserved grooming receipt must be displayed in the windshield of the vehicle. **Any vehicle that connects to electricity by the stables will be charged for reserved grooming. If you would like reserved parking and grooming please fill out reserved grooming form in advance and mail it in with payment to reserve your space.**

There is no parking on the grass except for reserved and paid motor homes in their assigned spaces.

All Motor Homes must park in a designated area

Admission to Show March 30, 2019

\$5.00 Adult - \$2.00 Children 6 to 12, Senior Citizens and Children under 6 are Free.

***Important to know : you will be asked for your dog's entry form at the GATE to be admitted for free. One free admission for each dog entered.** Having dogs in your vehicle does not prove your dog is entered. **If you do not provide the entry ID, you will be charged admission to the show. No exception.** This regulation applies to dogs entered in conformation, obedience & rally. Dogs **not** entered and **not** competing are **not** allowed on show grounds .

Please Note: Tropical Park Rule.

There is **No** overnight camping allowed except in camping area. Any vehicle found in other area will be towed at owner's expense.

Exhibitors and Handlers will be held responsible for clean conditions in and around their crates & parking spaces. **Anyone not cleaning up after their dogs will be subject to an event committee hearing.**

CRATES ALLOWED RINGSIDE ONLY FOR THE DURATION OF JUDGING & MUST BE REMOVED IMMEDIATELY AFTERWARD.

There will be no grooming in show areas. There will be very few chairs available at this location.

Bring your own chairs.

Soft sided crates only allowed ringside while dogs are waiting to be shown. No dogs are to be left unattended in soft sided crates. Crates must be stacked due to limited space.

No roping off of space. This will be strictly enforced due to limited space.

Exhibitors must be governed by any rules or regulations of civil authorities and/or building or location. Please, obey all posted signs.

No strollers in arenas. (IN ACCORDANCE WITH FIRE CODE).

Vehicles parked in restricted zones will be towed at owner's expense.

Paid parking Voucher must be displayed on windshield at all times.

Novice Senior 15 & under 18 yrs • Open Senior 15 & under 18 yrs
Master Class

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

Master Class - will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

No entry may be changed or cancelled unless notice of the change or cancellation is received in writing by the Superintendent or Show Secretary named in the premium list to receive entries, prior to the closing date and hour for entries, except that a correction may be made from one age division to another, as well as, move from Master to Open or Open to Novice if a win has been disallowed or the Junior miscalculated number of placements, provided this transfer is made by the Superintendent or Show Secretary prior to the judging of the class at the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department (919) 233-9767.

AKC NATIONAL OWNER-HANDLED SERIES

Sunday, March 31, 2019

Exhibitors must declare their dog AKC National Owner-Handled Series eligible at the time of entry using the check box on the entry form.

The handler must be an owner of record according to the AKC's records as of the date of the show.

Dogs declared eligible will be identified by an asterisk or other representative mark in the steward's book and in the show catalog.

*Professional handlers, household members and current assistants to professional handlers may not exhibit. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/ weekend.

Dogs must be handled by an owner-handler eligible for the AKC National Owner-Handled Series throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. Additionally, dogs must be handled by an eligible owner-handler for all AKC National Owner-Handled Series competition.

The Owner-Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non-regular classes. *This excludes all dogs defeated during class and winners competition for the regular show.*

If the Best of Breed/Variety winner of the regular show is eligible for the AKC National Owner-Handled Series competition, it will also be awarded Owner-Handled Best of Breed. In this case the dog will be eligible to compete in group competition for the regular show and group competition for the AKC National Owner-Handled Series.

If the regular show Best of Breed/Variety winner is not eligible for AKC National Owner-Handled Series competition and the regular show Best of Opposite Sex to Best of Breed/Variety is eligible, the regular show Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed.

If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety from the regular show is eligible for the AKC National Owner-Handled Series competition and both the Select Dog and Select Bitch are eligible, the judge is to choose Owner-Handled Best of Breed from the Selects and any eligible Winners Dog or Winners Bitch.

If one of the Selects from the regular show is eligible for AKC National Owner-Handled Series competition, excuse all eligible champions and non-regular class winners of the same sex and then choose Owner-Handled Best of Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.

If the regular show Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog who competed in Best of Breed including Winners Dog or Winners Bitch as the Owner-Handled Best of Breed.

If no dog remaining in the ring is eligible for the AKC National Owner-Handled Series competition, Owner-Handled Best of Breed will not be awarded and the breed/variety will not be represented in group competition for the AKC National Owner-Handled Series.

**Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay or received payment for handling a dog within the last five years.*

USE OF RAMPS

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotto Romagnolo, Spaniels (American Water), Spaniels (Clumber), Spaniels (English Springer), Spaniels (Field), Spaniels (Welsh Springer), Cirneco dell'Etna, Standard Schnauzer, American Staffordshire Terrier, Irish Terrier, Kerry Blue Terrier, Soft Coated Wheaten Terrier, Staffordshire Bull Terrier, Finnish Spitz, Keeshonden, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdog, Norwegian Buhund, Polish Lowland Sheepdog, Spanish Water Dog, Mudi (Misc), Norrbottenspets (Misc).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Spaniels (Boykin) and Whippets.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei, and Chow Chows.

This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. Ramps can be used in emergency situations to judge any breed. In emergency situations where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.
